1. The PARC will review your program and formulate a recommendation. The committee will advise you of the recommendation by March 2026.
2. The recommendation will be received and acted upon by the Board of Directors at its April 2026 meeting, with notification of your accreditation award sent to you by May 2026.

Please note that no recommendation is official until acted upon by the Board of Directors.
